FOOD VENDOR GUIDELINES

The Rotary Club of Mariposa Yosemite's Art, Wine and Wheels event brings art, wine, vintage cars, food and music together in a beautiful outdoor setting. So that everyone has an enjoyable experience we ask that you review and follow the guidelines below:

- 1. The EVENT will be held on Saturday, May 24th, 2025 from 11:00 AM 5:00 PM In front of and adjacent to the Mariposa County Courthouse. Please be in place by 9:00-9:30 AM and ready to serve by 10:30 (The road to the food court area will be closed off at 9:30 for safety).
- 2. Your Space will be assigned by Rotary, and will be approximately 10' x 10' for a food pop up booth, or the approximate length of your trailer if you are a food truck. You will need to provide (if applicable) your own tables, chairs, menu display, shade canopy. Tents/canopies must be flame retardant. You are requested to park your car about a block away during the event to allow for more customer parking.
- 3. The Registration Fee for Food Vendors is \$75, and must be received by February 28th to reserve your spot. After that date it is first come, first served, as we have a very limited number of food vendor spaces. No commission on sales is charged, and the registration fee is nonrefundable.
- 4. Participants should remember this is an outdoor event and is subject to inclement weather (rain, wind, etc.). The Rotary Club will cancel the event <u>only under extreme weather conditions.</u> The vendor should be aware that the Rotary Club will not accept any responsibility for goods damaged due to inclement weather or any other reason. Vendor must make their own decisions regarding participation. No rain date has been considered.
- 5. Please be ready to provide a copy of your Commercial Kitchen License and One Day Permit from the Health Department to Rotary at least a week before the event, and display these for the public at the event.
- 6. Email photos of your business, yourself, signs, your food, your logo etc. to Jennivieve Harper at jennivieve@hotmail.com and also to Susan Robinson at srobinson@sti.net for advertising on social media and in our Event brochure.
- 7. Please complete both application forms (3 pages), and mail them with your check or money order for \$75 as soon as possible. You will be confirmed within two weeks of receipt of applications and payment. We will turn your completed health department application in to Mariposa County.
