- 1. The event will be held on Saturday, May 24, 2025 from 11:00 AM to 5:00 PM on the Mariposa County Courthouse Lawn. Arrive by 10:30am and see Eric Weihe for assigned parking space.
- 2. Parking spaces will be assigned by Rotary on the south side of the Courthouse. You will need to provide your own tables, chairs, and shade canopy, as necessary for your comfort. Tents and canopies must be flame retardant.
- 3. 1st, 2nd and 3rd Place will be judged during the Festival. Winners will be announced near the end of the Festival.
- 4. Registration is requested by May 1, 2025 Participants should remember this is an outdoor event and is subject to inclement weather (rain, wind, etc.). The Rotary Club will cancel the event <u>only</u> <u>under extreme weather conditions.</u> You should be aware that the Rotary Club will not accept any responsibility for damage due to inclement weather or any other reason. Owners must make their own decisions to participate or not. No rain date has been considered.
